We should also develop a long term (at least 5 years) plan with an associated financial plan. That way we know, with some flexibility, how we can accomplish what is important to us.

As I see it there are several ways to deal with our finances, in no particular order and not all inclusive they include:

- Raise our annual dues
- Develop program or initiative based funding. An example might be, if you want to support our Wreaths Across America program, then we provide you a way to buy some wreaths for our chapter.
- We already established a **Smile.Amazon** account. If you chose to use it with us as your charity, we receive .5% of your purchase as a donation to our chapter. That will help us some.
- Conduct fundraising events.

We can do any of these things alone or collectively in any combination. I assure you this will be a significant topic of discussion at our June meeting. You should consider coming to the meeting and helping us figure out how we want to move forward and how we want to responsibly fund our goals.

# Chapter Spotlight!

The Editor of The SERAPIS will ask for a Biography to be featured in each Newsletter, to help familiarize our members to each other. This edition, I asked our newly-installed **President MARK DEEDS** to submit his Biography for a Feature in this edition. I extend my thanks to him. This Biography, in his-own words...

I am the product of a small Midwestern town upbringing. My father was a minister and we moved every couple of years in very small farming towns (population 200 to 450) throughout Iowa and Missouri. Everyone knew everyone else, there were no dial phones, party lines and the Minister's kids (PKS as we were known) were always a central topic for gossip. I am strongly influenced by that upbringing; the central plains family farmers lived a very independent, 'get out of my way', 'I will fix it' and 'my word is my bond' mentality. I believe I still carry a lot of that ideology and work ethic with me.

My government career began with the number "54". On the first day of having my own personal government number, our local draft board announced they were calling all numbers up to and including "42". I knew my time was short, so I decided to join our Armed Forces. The early seventies was a difficult time for the military.

The Viet Nam conflict was nearing its end, the military's morale was almost as low as the budget they received. Significant portions of the public believed the military was at fault for the results of the war and the soldiers personally felt that rebuff. From that beginning to the end of my military career, I was always proud to wear my country's uniform. My career took me to many places throughout the world. I always left those places knowing how fortunate I was to be born in the United States of America and I developed a very strong pride for my country.

As my military career came to an end, I knew that one retirement was not enough to enjoy the good life. So I exchanged my uniform for a suit and became a Federal civil servant. In my new career, I supported the military I came to love. For the next twenty years I moved around our government doing my best to make a difference for our War Fighters; to provide them with the information and knowledge they needed to be successful in whatever they were tasked to do.

After 40 years of serving my country, Sandy (with her own 40 years of service to our country) and I were able to retire and begin to focus on things we enjoy. I indulge my personal weakness, which is old cars. We have several toys and they keep me very busy. Each one demands time, attention and resources to keep them running. I often quip that I have OCCD (Old Car Collector Disorder) and what I know is there is no cure for this disorder and you always want another one.

I was always curious about my family history but I did nothing about finding out until I helped Sandy with her DAR package. After some research, I found the children of two Patriots married and created my family line. I also came to know the 'Deeds' family has a very rich and distinguished military heritage beginning in the Revolutionary War and includes the Civil War, World War I, World War II, the Korean War, the Vietnam War, and continues even now in Iraq and Afghanistan.

I came to the Sons of the American Revolution as a member of a patriotic family with a proud history and tradition of serving our country.

The Odenton Volunteer Fire Company recently relocated its flagpole for better visibility and has been recognized for doing so.





# General Horace Porter Award



Barrett L. McKown, past president of the John Paul Jones Chapter, awarded the General Horace Porter Award to the midshipman who contributed most to promote history within the History Department at the United States Naval Academy this last academic year.

The award was instituted in 1977and is named after Porter because of his steadfast determination to locate and have the remains of John Paul Jones returned to the United States from France. General Porter, a New Yorker and West Point graduate, served as the third President General of the SAR from 1892-1896.

He served as Ambassador to France for both Presidents McKinley and Roosevelt when he began his search for Jones.

The remains were found and returned to Annapolis on April 24<sup>th</sup>, 1906.

The awardee this year was Midshipman First Class **Ryan J. Mikalchus**, and the award was presented in Memorial Hall on the 22<sup>nd</sup> of May, 2019.



# The Bon Homme Richard vs HMS Serapis 23 September 1779

Such an exploit as that performed by John Paul Jones in 1779, by which, in plain sight of the English coast, he flung to the breeze the gallant ensign of the United States, and, with Britons as witnesses of his daring, fought, victoriously, a battle which has always been spoken of as the most obstinate and sanguinary combat that ever occurred between single ships, can never be read of by Americans with other than the deepest and most enthusiastic interest. The action may well be pronounced one of the most terrible on record, from its unusual duration for a naval battle, from the ferocity which the combatants displayed, and from the proximity of the two vessels, the muzzles of the ships' batteries almost reaching into each other's port-holes.

This action, which gave the most distinguishing renown to Jones' brilliant career, and which so early gave prestige to American prowess on the ocean, is that which occurred on the 23rd of September, 1779. It was about noon, and a fleet of over forty sail appeared off Flamborough Head, on the coast of Yorkshire. The sails in sight were a fleet of English merchantmen, under convoy of the ships-of-war HMS Serapis and HMS Scarborough. Jones' ship the Bon Homme Richard set every stitch of canvas, but did not come into fighting position until about seven o'clock in the evening.

Captain Cottineau, of the Pallas, engaged the Scarborough, and took her after an hour's action, while the Ban Homme Richard engaged the Serapis. The British colors were struck at half past ten o'clock. However, so terribly was the Bon Horn me Richard cut to pieces that she soon sank after Jones and his crew transferred aboard the Serapis.

Commodore Pearson surrendered his sword to his really weaker foe. In going through the formalities of this scene, Pearson said, "It is painful to deliver up my sword to a man who has fought with a halter around his neck."

"Sir," replied Jones, good humoredly, as he handed back the weapon, "you have fought like a hero, and I make no doubt but your sovereign will reward you in the most ample manner."

True enough, the gallant Pearson soon received from King George the dignity of knighthood as an acknowledgment of his bravery in this unparalleled battle. Hearing of the honor, Jones is said to have dryly remarked, "Well, he deserved it; and should I have the good fortune to meet with him again, I will make a lord of him!"

### YOUTH RECOGNITION AWARDS

The National Society Children of the American Revolution held their National Convention in Arlington, Virginia April 12-14 at the Renaissance Arlington Capitol View Hotel. Maryland CAR had a delegation of members attend, including outgoing State President Daniel Klein, and incoming State President Eva Bogino.

# Finding the Maryland 400 Project Update April 2019

During March 2019 we published five biographies, all of which were relatively detailed and lengthy.

#### They were:

- · Pvt. Christopher Beale, the last remaining Third Company biography;
- Cadet Tobias E. Stansbury, who rose to brigadier general in the militia in the War of 1812;
- Capt. Peter Adams, commander of the Sixth Company, later lieutenant colonel of the Seventh Maryland;
- · Ens. William Courts, of the Fourth Company, taken prisoner at Brooklyn; and
- Major Thomas Price, later colonel of the Second Maryland, who was accused of cowardice during his service.

In total, there are 755 biographies online, and most of our recent work has been devoted to revising biographies already online, so the total number isn't changing much.

The biography of Sergeant Alexander Naylor, Ninth Company, is undergoing revision with Cassy Sottile. When this is done, the only soldiers without a biography will be from the Fourth Independent Company. In addition, there are 8 biographies that need to be revised, all of senior officers; they were written for earlier MSA projects (such as the Biographical Dictionary of the Maryland Legislature, the governors' biographies, etc.). I am currently working on Thomas Marsh Forman, who joined the regiment as a cadet a week before the battle, and later served as Lord Sterling's aid de camp; he too, was a general during the War of 1812.

Taylor Blades will be starting as our staff researcher on April 22, and it will be very nice to have her in place. In addition, Washington College has selected two students to work as interns on the project this summer, who are funded through their Explore America internship program. One is Cassy Sottile, who was part of their Maryland 400 class last year and is currently interning with us; the other is Jillian Curran.

We have been busy recently in responding to quite a few inquiries about Revolutionary War service from members of the public, which came through the project website, the general MSA help desk, and our public search room. These types of question often don't involve members of the Maryland 400, but responding to them is an important way to connect with interested people about the project and MDSSAR's work.

In addition, I was invited to be the keynote speaker at the Veteran's Day ceremony at the Linthicum Veteran's Memorial, on November 9. I will pass on more details as I get them. I am also arranging a potential meeting with Chris Formant, author of Saving Washington.

### **STEPHEN BEARD**

Stephen was the fifth son of Richard Beard III and Mary. He is mentioned in the 1776 census as the householder for two men, 1 woman and 2 children. Bible records would have the woman as his wife-Elizabeth and the two children as his oldest-daughters Sara and Susanna. Revolutionary War records confirm his service as a "draught" on November 2, 1781 in Lieut. Clemons Company of Major Higgins Battalion.

Assessor records of 1783 in the Road (Rhode River) Hundred, upper part identifies Stephen as owning 262 acres of Beard's Habitation which his home had a household of seven. Additionally, he owned 52 acres of Townhill, an adjacent tract.

Stephen and Elizabeth had a total of eight children. On February 17, 1808 he married Susannah Rawling-. Stephen died between December 25, 1814 and January 21, 1815.

We (Beard Family) know very little about Stephen Beard who was referred to as a draught in Muster, Rolls and Other Records of Service of Maryland Troops In The American Revolution 1775-173 Peabody Library 975.2 A6733 Archives of Maryland XVIII Page 399.

We know Stephens father Richard III was an orphan after Richard's father Mathew died young and left his children to be raised by his aunt, Ruth and her husband Stephen Bordley. Stephens ownership of a portion of Beard's Habitation is likely owed to the two previous generations who settled Annapolis and Londontown. Richard Beard received the first land grant in Anne Arundel County from Lord Baltimore in 1649 and his son Richard, Jr performed the first surveys of Annapolis in 1684 and again in 1695.

Stephen's many children with Elizabeth were born before, during and after the Revolution between 1773 and 1794. If we know little about Stephen we know less about Elizabeth. We think they were married in 1772. We know nothing at this moment about her birth, death (or last name). We know Stephen married again in 1808 to Susan Rawlings.

Stephen's son Stephen Jr. born in 1782 married Margaret Rutland sold his portion of Beard's Habitation and together they moved to Rutland Road in 1802 where many Beard generations lived and still live today. Stephen Jr served in the defense of Washington in 1812 and later became Judge of the Orphans Court.
